## **PART - I: LETTER OF INVITATION**

### 1. INTRODUCTION

# 1.1<u>OBJECTIVE</u>

IHMCL intends to engage agencies/service providers, with prior experience in ETC tolling or Multi lane free flow tolling, to provide RFID based multi lane free flow (MLFF) tolling solution on selected stretch. The primary objective of Multi-lane free flow (MLFF) RFID gantry-based tolling pilot is to develop a proof of concept and establish the effectiveness of RFID technology, with the exact same ISO 18000-6C standard as currently used in India, to enable tolling at high speed and high traffic highway road networks with significant level of accuracy.

The information is required to be captured by gantries for analysis purpose only and for establishing comparison with data at nearest toll plaza. The pilot gantries shall not be used for toll amount deduction of passing vehicle.

### **1.2 GENERAL INFORMATION**

# 1.3 **DEFINITIONS**

**"Commencement date"** means the date upon which the Service Provider receives the notice to commence the work issued by IHMCL.

**"Contract"** shall mean & include RFP, Notice for Inviting Tender (NIT), the tender documents and letter of acceptance thereof and the formal agreement, to be executed between IHMCL and the Service Provider together with the complete documents referred to therein including the conditions with appendices and any special conditions, the

specifications, designs, drawings, bill of quantities with rates and amounts. All these documents taken together shall be deemed to form one Contract and shall be complementary to each other

### 3. BID CONDITIONS

## 3.1 INFORMATION

The Bidders are invited to submit Technical, and Financial Proposals (collectively called as "The Proposal"), as specified in this RFP, for providing "Pilot of Multi-Lane Free Flow barrier-less tolling using Radio Frequency (RFID) technology system on Delhi-Chandigarh project corridor at NH-44 on Design, Build, Finance, Operate and Maintain basis". Details on the format(s) of submission and list of necessary supporting documents are provided in following sections.

Website for accessing RFP is <u>http://etenders.gov.in</u>. The Bidders shall submit the proposal as per criteria laid down in the RFP. The tender process timelines are mentioned in the section – "Part – II: Schedule of the Tender" above.

### 3.2 BIDDING FEES

- a. Document Fee: The document fee shall be submitted, as a part of the proposal, in the form of Bank Draft of INR 5,000/- (INR Five Thousand only) from a scheduled Indian Bank approved by RBI drawn in favour of "Indian Highways Management Company Limited" payable at New Delhi, India, as a non-refundable processing fee. Proposals not containing the document fees will be rejected.
- b. Bid Security/Earnest Money Deposit (EMD): The bid security/Earnest Money Deposit (EMD) for a sum of INR 5,00,000/- (INR Five Lakh) shall be submitted, as a part of the proposal, in the form of a Demand Draft, from a scheduled Indian Bank approved by RBI drawn in favour of "Indian Highways Management Company Limited", valid up to 180 (one hundred and eighty) days from the date of receipt of proposal, payable at New Delhi. Proposals not containing the earnest money deposit will be rejected.

IHMCL will not be liable to pay any interest on bid security deposits. Bid security of technically qualified but unsuccessful Bidders shall be returned, without any interest, within two months after acceptance of LOA by selected Bidder or when the selection process is cancelled by the IHMCL. The Successful Bidder's Bid Security shall be returned, without any interest, post the Successful Bidder signing the contract and furnishing the Performance Security in accordance with provisions of the RFP and contract.

IHMCL will be entitled to forfeiture and appropriation of the bid security as mutually agreed loss and damage payable to IHMCL in regard to the RFP without prejudice to the IHMCL's any other right or remedy under the following conditions:

- (i) If a Bidder engages in a corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice as envisaged under this RFP (including the Standard Form of Contract);
- (ii) If any Bidder withdraws its Proposal during the period of its validity as specified in this RFP and as extended by the Bidder from time to time,
- (iii) In the case of the Successful Bidder, if the Successful Bidder fails to sign the contract or provide the Performance Security within the specified time limit, or
- (iv) If the Bidder commits any breach of terms of this RFP or is found to have made a false representation to IHMCL.

# 3.3 GENERAL

IHMCL defines, for the purposes of this provision, the terms set forth below:

- a. IHMCL reserves the right to make inquiries with any of the Clients listed by the Bidders in their previous experience record. If it determines that the Bidder has, directly or indirectly or through an agent, engaged in corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice (collectively the "Prohibited Practices") in the Selection Process, IHMCL will, without prejudice to its any other rights or remedies, consider forfeiture and appropriation of the Bid Security, as mutually agreed genuine pre-estimated compensation and damages payable to IHMCL for, inter alia, time, cost and effort of IHMCL, in regard to the RFP, including consideration and evaluation of such Bidder's Proposal.
- b. IHMCL will reject a proposal for award if it determines that the Bidder has engaged in corrupt or fraudulent activities in competing for the contract in question.

- c. IHMCL will declare a Bidder ineligible, either indefinitely or for a stated period of time, to be awarded a contract if it at any time determines that the Bidder has engaged in corrupt or fraudulent practices in competing for and in executing the contract.
- d. For the purposes of this RFP, the following terms shall have the meaning hereinafter respectively assigned to them:
  - "Corrupt Practice" means the offering, giving, receiving, or soliciting, directly or (i) indirectly, of anything of value to influence the action of any person connected with the Selection Process (for avoidance of doubt, offering of employment to or employing or engaging in any manner whatsoever, directly or indirectly, any official of IHMCL who is or has been associated in any manner, directly or indirectly with the Selection Process or the LOA or has dealt with matters concerning the Agreement or arising there from, before or after the execution thereof, at any time prior to the expiry of one year from the date such official resigns or retires from or otherwise ceases to be in the service of IHMCL, shall be deemed to constitute influencing the actions of a person connected with the Selection Process; or save as provided herein, engaging in any manner whatsoever, whether during the Selection Process or after the issue of the LOA or after the execution of the Agreement, as the case may be, any person in respect of any matter relating to the Project or the LOA or the Agreement, who at any time has been or is a legal, financial or technical consultant/ adviser of IHMCL in relation to any matter concerning the Project;
  - (ii) "Fraudulent Practice" means a misrepresentation of facts in order to influence the selection process or the execution of a contract in a way which is detrimental to IHMCL, and includes collusive practices among suppliers (prior to or after submission of proposals) detailed designed to establish prices at artificial, noncompetitive levels and to deprive the IHMCL of the benefits of free and open competition.
  - (iii) "Coercive practice" means impairing or harming or threatening to impair or harm, directly or indirectly, any persons or property to influence any person's participation or action in the Selection Process;

- (iv) "Undesirable practice" means establishing contact with any person connected with or employed or engaged by IHMCL with the objective of canvassing, lobbying or in any manner influencing or attempting to influence the Selection Process; or having a Conflict of Interest;
- (v) "Restrictive practice" means forming a cartel or arriving at any understanding or arrangement among Bidders with the objective of restricting or manipulating a full and fair competition in the Selection Process.
- e. Confidentiality: Information relating to evaluation of proposals and recommendations concerning awards of contract shall not be disclosed to the Bidders who submitted the proposals or to other persons not officially concerned with the process, until the winning firm has been notified that it has been awarded the contract.
- f. Right to reject any or all Proposals:
  - (i) Notwithstanding anything contained in this RFP, IHMCL reserves the right to accept or reject any Proposal and to annul the Selection Process and reject all Proposals, at any time without any liability or any obligation for such acceptance, rejection or annulment, and without assigning any reasons thereof.
  - (ii) Without prejudice to the generality of above, IHMCL reserves the right to reject any Proposal if:
    - at any time, a material misrepresentation is made or discovered, or
    - The Bidder does not provide, within the time specified by IHMCL, the supplemental information sought by IHMCL for evaluation of the Proposal.
  - (iii) Such misrepresentation/improper response by the Bidder may lead to the disqualification of the Bidder. If such disqualification/rejection occurs after the Proposals have been opened and highest-ranking Bidder gets disqualified/rejected, then IHMCL reserves the right to consider the next best Bidder, or take any other measure as may be deemed fit in the sole discretion of IHMCL, including annulment of the Selection Process.
- g. The Bidder is required to follow the highest level of work ethics, if any member of the Bidder's organization has a Conflict of Interest or indulge in "Prohibited Practices"; the proposal is liable to be disqualified. Further, in the event any entity has been barred by

the Central Government, any State Government, a statutory authority or a public sector undertaking, as the case may be, from participating in any project or bid, and the bar subsists as on the date of Proposal submission Date, it would not be eligible to submit a Proposal.

- h. Bidders shall bear all costs associated with the preparation and submission of their proposals, and their participation in the Selection process, and presentation including but not limited to postage, delivery fees, expenses associated with any demonstrations or presentations which may be required by IHMCL or any other costs incurred in connection with or relating to its Proposal. The IHMCL is not bound to accept any Proposal, and reserves the right to annul the selection process at any time prior to Contract award, without thereby incurring any liability.
- i. After submission of the proposals by the Bidder, to the satisfaction of IHMCL, if clarifications are required or doubt arises as to the interpretation of anything included in the submitted documents, the bidder shall, on receipt of written request form IHMCL, furnish such clarification to the satisfaction of IHMCL within five (05) working days without any extra charge.
- j. The Successful Bidder shall not accept or engage in any assignment that may place it in a position of not being able to carry out the assignment in the best interests of IHMCL and the Project.
- k. Acknowledgement by Bidder:
  - (i) It shall be deemed that by submitting the Proposal, the Bidder has:
    - made a complete and careful examination of the RFP;
    - accepted the risk of inadequacy, error or mistake in the information provided in the RFP or furnished by or on behalf of IHMCL;
    - satisfied itself about all matters, things and information, including matters herein above, necessary and required for submitting an informed Application and performance of all of its obligations there under;
    - acknowledged that it does not have a Conflict of Interest; and
    - agreed to be bound by the undertaking provided by it under and in term hereof.

(ii) IHMCL and/ or its advisors/ consultants shall not be liable for any omission, mistake or error on the part of the Bidder in respect of any of the above or on account of any matter or thing arising out of or concerning or relating to RFP or the Selection Process, including any error or mistake therein or in any information or data given by IHMCL and/ or its advisors.

## 3.4 PRE-BID MEETING

- a. Pre-Bid Meeting of the Bidders will be convened at the designated date, time as specified in the Key Dates at IHMCL Office, 2nd Floor, MTNL Building, Sector-19, Dwarka, New Delhi – 110075 or any other location as specified by IHMCL. A maximum of two representatives of each Bidder will be allowed to participate on production of an authorization letter from the Bidder.
- b. The Bidders who are interested in attaining the pre-bid meeting should confirm IHMCL about the participation one day prior to the schedule. The confirmation can be sent to *tenders@ihmcl.com*.
- c. During the course of Pre-Bid Meeting, the Bidders will be free to seek clarifications and make suggestions for consideration of IHMCL. IHMCL will endeavour to provide clarifications and such further information as it may, in its sole discretion, consider appropriate for facilitating a fair, transparent and competitive selection process.

#### 3.5 PREPARATION OF PROPOSAL

- a. Bidders are requested to submit their Proposal in English language and strictly in the formats provided in this RFP. IHMCL will evaluate only those Proposals that are received in the specified forms and complete in all respects.
- b. In preparing their Proposal, Bidders are expected to thoroughly examine the RFP Document. Material deficiencies in providing the information requested may result in rejection of a Proposal.
- c. Client certifications or Purchase orders for the projects listed under the experience section: The certifications and/or PO must confirm the project attributes (size, fee, duration etc.) and the scope of work of the projects. The self-certification of the Bidder

is also permitted accompanied by certified copy of work order/document certifying release of performance bank guarantee/ certified copy of payment received or any other document certifying the completion/part completion of the project as the case may be. Bidders are required to submit the details of project completion Self Certificate as per Annexure – I.

- d. The technical proposal must not include any information on the financial bid.
- e. Failure to comply with the requirements spelt out in this RFP shall lead to the disqualification of the bidder.
- f. Bidders should note the Proposal Due Date, as specified in the section "Part II: Schedule of the Tender", for submission of Proposals. Except as specifically provided in this RFP, no supplementary material will be entertained by IHMCL, and that evaluation will be carried out only on the basis of Documents received by the closing time of Proposal Due Date as specified in the section – "Part II: Schedule of the Tender". Bidders will ordinarily not be asked to provide additional material information or documents subsequent to the date of submission, and unsolicited material if submitted will be summarily rejected. For the avoidance of doubt, IHMCL reserves the right to seek clarifications in case the proposal is non-responsive on any aspects.
- g. The Financial Proposal should be inclusive of all the costs of pilot including applicable taxes, duties, levies, permit, fees, entry fees, manpower, transportation charges, equipment insurance fees, custom duty, handling charges etc., except the Goods and Services Tax (GST) which shall be paid as per applicable rates. While submitting the Financial Proposal on e-tender portal, the Bidder shall ensure the following:
  - (i) All the costs associated with the Assignment shall be included in the Financial Proposal.
  - (ii) The total amount indicated in the Financial Proposal shall be without any condition attached or subject to any assumption, and shall be final and binding. In case any assumption or condition is indicated in the Financial Proposal, it shall be considered non-responsive and liable to be rejected.
  - (iii) The proposal should be submitted on e-tender portal as per the standard Financial Proposal submission forms prescribed in this RFP.

- (iv) Bidders shall express the price in Indian Rupees.
- (v) Bidders must do their due diligence about the tax implications and IHMCL will not be liable for any incident.
- h. The Proposals must remain valid for a period of 120 days from date of submission of proposal. During this period, the selected bidder is expected to keep available the professional staff proposed for the assignment. If IHMCL wishes to extend the validity period of the proposals, it may ask the bidders to extend the validity of their proposals for a stated period. The bidder will be required to extend the validity period without any additional financial implication to IHMCL.

### 3.6 SUBMISSION, RECEIPT AND OPENING AND EVALUATION OF PROPOSALS

**a.** IHMCL has adopted the following process (referred to as the "Bidding Process") for selection of the qualified Bidder. All documents need to be submitted on e-tender portal.   - **ii.** Bidder's authorized representative may attend the opening, and those who are present shall sign the Attendance Sheet evidencing their attendance.
  - iii. The Bidder's names, bid modifications or withdrawals and such other details as IHMCL at its discretion, may consider appropriate, will be announced at the time of opening.

iv. Physical Documents shall be opened first and based upon the evaluation of these documents, IHMCL shall announce the names of the Bidders who have qualified for opening of Financial Bids. It is hereby clarified that Financial Bids of only such Bidders who are declared qualified as stated herein shall be opened.

### c. Examination and Evaluation of Bids

**i.** Any time during the process of evaluation, IHMCL may seek for clarifications from any or all Bidders. Failure of any Bidder to provide the required clarifications within the stipulated timeline may result in rejection of its Bid, at the sole discretion of IHMCL.

# ii. <u>Phase-1: Physical Evaluation</u>

The following documents shall be verified as part of physical evaluation Document fee: - The document fee (non-refundable) of Rs. 5,000/- (Rupees Five Thousand only) in the form of a demand draft drawn in favour of "Indian Highways Management Company Limited" drawn on any Scheduled bank payable at New Delhi shall be submitted by the Applicant.

EMD: - The envelope containing EMD and other relevant documents as required by this RFP will be opened. All the documents shall require to be as per format prescribed in the RFP. At any stage during the entire Bid evaluation process, if the EMD is found to be invalid, the respective Bidder's Bid shall be summarily rejected. If Physical Documents submitted by the Bidder has the Financial Bid details, the Bid shall be summarily rejected.

The Bidder shall furnish, as part of the Bid, Earnest Money Deposit (EMD) for an amount INR 5,00,000/- (Rupee Five Lakh only) The Successful Bidder's EMD will be returned, without any interest, upon the Successful Bidder signing the Contract and furnishing the Performance Security in accordance with the provisions thereof. IHMCL may, at the Successful Bidder's option, adjust the amount of EMD in the amount of Performance Security to be provided by him in accordance with the provisions of the Contract. The Earnest Money shall be in the form of a demand draft drawn in favour of "Indian Highways Management Company Ltd." on any Scheduled bank payable at New Delhi.

Upon furnishing of the Performance Security by the Successful Bidder, IHMCL will promptly notify the other Bidders that their Bids have been unsuccessful.

EMDs of unsuccessful Bidders will be returned back to them after signing of Contract with the Successful Bidder or after the expiry of the validity period of the Bids, whichever is earlier.

# iii. Other documents as specified the RFP

The Technical Bids will be evaluated by an Evaluation Committee. The Bidder shall have to fulfil all the Eligibility Criteria as specified in the RFP. The Bidder shall have to submit all the required documents and forms specified as per Annexure A – Annexure G (excluding Financial Proposal) physically. These documents will be scrutinized in this phase of evaluation. Those Bidders who do not fulfil the terms and conditions of Eligibility Criteria as specified in this tender will not be eligible for further evaluation.

Evaluation of Technical Bids by the Evaluation Committee shall not be questioned by any of the Bidders. IHMCL may ask Bidder(s) for additional information, visit to Bidder's site and/ or arrange discussions with their professional, technical faculties to verify claims made in Technical Bid documentation from the Bidder on the already submitted Technical Proposal at any point of time before opening of the Financial Proposal.

- iv. Evaluation of submitted bids:
  - a. The evaluation committee appointed by IHMCL will carry out the technical evaluation of Proposals of bidders based on the documents submitted, as mentioned in subsequent sections.
  - b. The technical proposal should contain a technical presentation in PDF format, which can showcase the Bidder's experience at all projects of implementing Multi Lane Free Flow (MLFF) Tolling System or RFID based ETC tolling system.

- vi. <u>Phase 3: Financial Evaluation</u>
  - a) Financial score: -
  - The Financial Bids of ONLY the Bidders who are declared as qualified in Phase
     1 and have Technical Score of minimum 60 marks after Technical Evaluation
     will be opened.
- ii. The Financial Bid Evaluation will be based on the "Total Cost of Pilot", quoted by the Bidder which would be the basis for total pay-outs, but will exclude the GST (if applicable).

### d. Selection and award criteria: -

The Bidders shall be ranked based on their Composite Scores. The Bidder who has secured the highest Composite Score shall be considered to be the Successful Bidder.

### e. <u>Responsiveness of Bids: -</u>

IHMCL shall determine as to whether each bid is responsive to the requirements of this RFP document. A bid will be declared non-responsive in case:

- a) If the Authorized Signatory holding Power of Attorney and Signatory are not the same
- b) If a bidder submits a conditional bid or makes changes in the terms and conditions given in this RFP document
- c) Failure to comply with all the requirements of RFP document by a bidder
- d) If the financial bid is not submitted in the formats prescribed in the RFP document
- e) If any requisite document/ certificate is not in the prescribed format the same shall not be considered while evaluating the Bids and the same may lead to Bid being declared as non-responsive.
   and
- f) The bid contains any pre-condition, assumption or qualification;
- f. No proposal shall be accepted after the due date and time for submission of Proposals as specified in "Part – II: Schedule of the Tender".

- **g.** After the Proposal submission until the contract is awarded, if any Bidder wishes to contact IHMCL on any matter related to its proposal, it should do so in writing at the Proposal submission address. Any effort by the firm to influence IHMCL during the Proposal evaluation, Proposal comparison or contract award decisions may result in the rejection of the Bidder's proposal.
- **h.** The bidder can use the experience of a company which controls, is controlled by, or is under the common control with such bidder. The 'control' means the ownership, directly or indirectly, of more than 50% (fifty per cent) of the voting shares of such bidder, as on the Bid Due Date. In such case, the bidder shall submit the following documents:
  - A certificate from the bidder's statutory auditor/ chartered accountant certifying the relationship between the bidder and the company whose experience is being shown along with the percent of voting shares under common control.
  - A letter of support, in form of undertaking, from the company whose experience is being shown as relevant experience that it will provide necessary technical and financial support to the Bidder in implementation of the project.

#### 3.7 IMBALANCED BID

If the Bid of the Successful Bidder is seriously imbalanced in relation to IHMCL's estimate of the cost of work to be performed under the Contract, IHMCL may require the Bidder to produce detailed price analysis for any or all items of the Bill of Quantities, to demonstrate the internal consistency of the proposed System. After evaluation of the price analyses, IHMCL may require that the amount of the Performance Security set forth in the RFP be increased and an additional Performance Security may be obtained at the expense of the Successful Bidder to a level sufficient to protect IHMCL against financial loss in the event of default of the Successful Bidder under the Contract. The amount of the additional increased Performance Security shall be equal to the seriously imbalanced amount, which shall be final, binding and conclusive on the Bidder.

#### 3.8 PROCESS TO BE CONFIDENTIAL

Information relating to the examination, clarification, evaluation, and comparison of Bids and recommendations for the award of a Contract shall not be disclosed to Bidders or any other persons not officially concerned with such process until the award to the Successful Bidder has been announced. Any attempt by a Bidder to influence IHMCL's processing of Bids or award decisions may result in the rejection of his Bid.

#### 3.9 CLARIFICATION AND AMENDMENT OF RFP DOCUMENTS

a. Bidders may seek clarification on this RFP document no later than the date specified in the Schedule of the Tender. IHMCL reserves the right to not entertain any queries post that date. # 3.11 AWARD OF CONTRACT

a. After selection, a Letter of Award (the "LOA") will be issued by IHMCL to the Successful Bidder and the Successful Bidder shall, within 7 (Seven) days of the receipt of the LOA, sign and return the duplicate copy of the LOA in acknowledgement thereof. In the event the duplicate copy of the LOA duly signed by the Successful Bidder is not received by the stipulated date, the IHMCL may, unless it consents to extension of time for submission thereof, appropriate the EMD of such Bidder as mutually agreed genuine pre-estimated loss and damage suffered by IHMCL on account of failure of the Successful Bidder to acknowledge the LOA, and the second lowest cost (i.e. L2) Bidder may be proposed to perform the work as per rates quoted by L1 bidder.

b. Performance Security: Within 15 (Fifteen) days of the receipt of the Letter of Award, the Successful Bidder shall submit an irrevocable and unconditional Bank guarantee issued in the name of IHMCL for an amount equal to 10% of the Total Bid Price (value of awarded work), issued by a Bank described under this RFP which shall be verified at any branch located in the National Capital territory of Delhi and through SFMS mode as performance security for the due performance of its obligations under the Contract.

The aforesaid Bank Guarantee shall be as per the format given in format provided in this RFP and will be valid for a period till Contract period after the expiry of Contract period and shall also have a minimum claim period of 1 year.

- c. c) All payment will be subject to penalty and/or adjustments as per conditions mentioned in this document and shall be released within 30 days from the date of undisputed invoice.

# 3.14 DAMAGES

a. Delay in design, engineering & installation: - If service contractor fails to supply, design, and engineer and install the gantry based design as per timelines, penalty of Rs. 50,000/- per day upto maximum of Rs. 50,000/- shall be applied.

In case of delay beyond 20 days, IHMCL may consider termination of contract or forfeiture of the performance security or both.

- Each issue/concern highlighted during the contract period must be addressed within 24 hours of written notice/email from IHMCL. For which start time shall be the time of email forwarded/issued by IHMCL.
- c. Any delay in rectification of issue during the service period, except in Force Majeure situations, shall attract penalty of INR 5,000/- (Five Thousand Indian Rupees) per day subject to a maximum of INR 50,000/- (Fifty Thousand Indian Rupees) for each instance.
- d. Damages shall be payable by the Service Provider within 5 days of imposition thereof by IHMCL, failing which the same shall be deducted from the payments to be made to the Service Contractor or from the Performance Security as deemed appropriate by IHMCL.
- e. At any time during Contract Period, if IHMCL observes that there are significant variations in observed results and the performance level required (specified in relevant sections of RFP), IHMCL shall have the right to terminate the Contract Agreement and consider forfeiture of the security deposit. In such case, IHMCL may consider, at its sole discretion, any of the following recourse:
  - (i) instruct the successful bidder to install Corrective measures (ref. Annexure A) at no additional cost to IHMCL (failure to comply to the same by the successful bidder will be considered a breach of contract conditions), or
  - (ii) award the contract/work to the next lowest cost bidder (i.e. L2), or
  - (iii) Take any action as may be deemed fit to IHMCL.
- f. The Vendor needs to ensure that the Civil work involved in laying of gantries and other relevant equipment is done with minimal disruption to traffic on the highway. In case the Vendor's plan requires disruption to traffic, the same has be submitted to IHMCL for approval and the work should not be started with approval from IHMCL on the matter. Also, the work should not cause any damage to the highway. If the work plan involves potential damages to the highway, a detailed plan regarding damage and course for correction should be submitted to IHMCL and approval be sought before proceeding with the same.

# 3.15 PERFORMANCE SECURITY

Within 15 (ten) days of the receipt of the Letter of Award, the Successful Bidder shall submit an irrevocable and unconditional Bank Guarantee issued in the name of IHMCL for an amount equal to 10% of the Total Bid Price (value of awarded work) issued by a Bank described under this RFP which shall be verified at any branch located in the National Capital territory of Delhi and through SFMS mode as performance security for the due performance of its obligations under the Contract.

The aforesaid Bank Guarantee shall be as per the format given in format provided in this RFP and will be valid for a period till Contract period after the expiry of Contract period and shall also have a minimum claim period of 1 year.

### 3.16 BANK GUARANTEE (BG)

The Bank Guarantee in the name of IHMCL issued by the following banks would only be accepted: -

- i. Any Nationalized Bank
- ii. Any Scheduled Commercial Bank approved by RBI having a net worth of not less than Rs. 500 crores as per the latest Audited Balance Sheet of the Bank. In the case of a Foreign Bank (issued by a branch in India), the net worth in respect of the Indian operations shall only be considered
- iii. A Foreign Bank (issued by a branch outside India) with a counter guarantee from any Indian Nationalized Bank.
- iv. Export Import Bank of India

The acceptance of the Bank Guarantees shall also be subject to the following conditions: -The capital adequacy of the Bank shall not be less than the norms prescribed by RBI. The bank guarantee issued by a Cooperative Bank shall not be accepted.

# 3.17 CORRUPT OR FRAUDULENT PRACTICES

IHMCL will reject a proposal for award and appropriate the EMD or the Performance Security, as the case may be, if it determines that the Bidder recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question. IHMCL will declare the Bidder ineligible, either indefinitely or for a stated period of time, to be awarded a contract by IHMCL if it at any time determines that the Bidder has engaged in corrupt or fraudulent practices in competing for the contract, or during execution.

"Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official or employee of IHMCL in the procurement process or in Contract execution. "Fraudulent Practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of IHMCL and includes collusive practice among Bidders (prior to or after bid submission) designed to establish bid process at artificial non-competitive levels and to deprive IHMCL of the benefits of free and open competition.

## 3.18 MISCELLANEOUS

- a. The Selection Process shall be governed by, and construed in accordance with, the laws of India and the Courts at New Delhi shall have exclusive jurisdiction over all disputes arising under, pursuant to and/or in connection with the Selection Process. IHMCL, in its sole discretion and without incurring any obligation or liability, reserves the right, at any time, to:
  - suspend and/or cancel the Selection Process and/or amend and/or supplement the Selection Process or modify the dates or other terms and conditions relating thereto;
  - (ii) consult with any Bidder in order to receive clarification or further information;
  - (iii) retain any information and/or evidence submitted to IHMCL by, on behalf of and/or in relation to any Bidder; and/or
  - (iv) Independently verify, disqualify, reject and/or accept any and all submissions or other information and/or evidence submitted by or on behalf of any Bidder.

# b. Force Majeure

- (i) No Party shall be considered in default of performance of its obligations under the terms of this Agreement, if such performance is prevented or delayed for any causes beyond the reasonable control of the Party affected by such event (hereinafter referred to as " Affected Party"), including, but not limited to, fire, flood, explosion, acts of God, public disorder, riots, embargoes, or strikes, acts of military authority, epidemics, strikes, lockouts or other labour disputes, insurrections, civil commotion, war, enemy actions which substantially bars the performance of obligations of the Affected Party (hereinafter referred to as "Force Majeure Event")
- (ii) **Reporting of Force Majeure**: If a Force Majeure Event arises in the aforesaid manner, the Affected Party shall maximum within 24 hours notify the other Party

in writing of such condition and the cause thereof. However, in case the Service Provider claims to have suffered force Majeure Event, the Service Provider shall continue to perform its obligations under this Agreement as far as is reasonably practical, and shall seek all reasonable alternative means for performance, unless otherwise directed by the IHMCL.

(iii) Mitigating the Force Majeure Event: Upon occurrence of Force Majeure Event, the Affected Party shall immediately take steps as are reasonably necessary to remove the causes resulting in Force Majeure if within its control and to mitigate the effect thereof. Any costs incurred and attributable to such event or curing of the Force Majeure Event shall be solely borne by the Affected Party.

#### **PART - IV: SCOPE OF WORK**

### 4. TERMS OF REFERENCE

# 4.1 BACKGROUND

- The total length of National Highways (NHs), the primary arterial road network in the country, at present is about 1,20,510 km. There has been phenomenal increase in length of NHs since Independence when the total length was about 21,378 km only. While, the total length of the primary arterial road network in the country is only about 1.9 % of the total length of road network of about 54.82 lakh kilometres, it carries more than ~40 % of the total traffic.
- 2. National Highways Authority of India was set up by an act of the Parliament, NHAI Act, 1988 "An Act to provide for the constitution of an Authority for the development, maintenance and management of national highways and for matter connected therewith or incidental thereto". It has been entrusted with National Highways Development Project, which along with other minor projects, has vested in it 50329 kms of National Highways for development, maintenance and management.

NHAI jointly with its Concessionaires and Financial Institutions incorporated Indian Highways Management Company Limited (IHMCL) on 26.12.2012 under the Companies Act, 1956 to carry out Electronic Tolling and other ancillary projects of NHAI.

3. The National Highways Act allows the Government of India to collect toll fare from the road users. Thus, the main sources of financing Road projects include cess levied on petrol and High Speed Diesel (HSD) and Tolling (either, by Government for public funded projects, or, by private concessionaires for BOT (Toll) / OMT projects). Of these, the revenue from tolling forms a major chunk to the overall financing budget of new such projects. Thus, the NHAI awards works for design, construction, operation and maintenance of highways to Concessionaires / Contractors. These Concessionaires / Contractors in turn collect the toll fares from vehicles at physical toll plaza booths across national highways.

- 4. Currently, the toll payment at toll plazas is either through cash or through Electronic Toll Collection (ETC) mode. This ETC mode is enabled by RFID based technology, wherein, an RFID sticker (FASTag) is affixed to the windshield of the vehicle and it is read by an RFID reader equipment installed at the toll plazas. Currently, these toll plazas are operated in barrier tolling mode.
- 5. The current toll design causes frequent disruption to traffic, especially on highly congested networks. This leads to an overall significant socio-economic loss to the country on account of toll plazas due to factors such as fuel cost of vehicles while waiting at toll plazas, passenger time value lost, opportunity cost of inventory due to toll plaza wait time, etc.
- 6. Moreover, the current design is incidence-based tolling where vehicles end up paying toll fare only if they cross a physical toll plaza. Thus, several vehicles using significant section of national highway do not pay any fare if they exit the highway just prior to encountering a plaza. On the other hand, some vehicles may end up paying toll fare for the entire project stretch even for using a small section of the highway, if the plaza falls on that small section used.
- 7. To address the problem of traffic disruption, NHAI/ IHMCL is exploring the option of RFID based Multi-lane Free Flow gantry system in India. Under this barrier-less gantry system, vehicles can cruise through tolling points without the need to slow down. At the same time, placing a gantry on every sub-stretch of a project will enable an effective implementation of pay-as-you-use tolling design.
- 8. To this extent, IHMCL now wishes to conduct a pilot for gantry based free flow tolling in India.

# 4.2<u>OBJECTIVE</u>

 The primary objective of Multi-lane free flow (MLFF) RFID gantry-based tolling pilot is to develop a proof of concept and establish the effectiveness of RFID technology, with the exact same ISO 18000-6C standard as currently used in India, to enable tolling at high speed and high traffic highway road networks with significant level of accuracy. The information is required to be captured by gantries for analysis purpose only and for establishing comparison with data at nearest toll plaza. The pilot gantries shall not be used for toll amount deduction of passing vehicle.

- 2. The scope of pilot consists of:
  - a. Designing the architecture of barrier-less gantries.
  - b. Installation of required equipment at points identified by IHMCL/NHAI.
  - c. Tracking and reporting of vehicles in the required data format.
  - d. Operating and maintaining both gantry software and hardware during the course of pilot duration.
  - e. Dismantling the infrastructure post the project is over and restoration of site to original condition.
  - f. Closing of all cases of damage, restoration etc.
  - g. Submit the report of handover of data to IHMCL with undertaking of no data held with them and the data collected by them shall not be used for any other purpose, except as provided in the RFP.

The detailed scope of the work is given in subsequent pages.

# 4.3 <u>SCOPE OF WORK</u>

IHMCL has outlined the following project stretch for the purpose of Multi-lane free flow RFID gantry-based tolling pilot.

The Pilot Project stretch will be on the Delhi-Chandigarh national highway corridor between the towns of Panipat and Ambala. The entire project stretch (a 6 lane highway) will include 3 sites where an MLFF barrier-less gantry will be placed at each point. The project stretch will include the required Right of Way (RoW) of Section of NH 44 on the Panipat to Karnal sub-stretch, Karnal to Nilokheri sub-stretch, Nilokheri to Kurukshetra sub-stretch, Kurukshetra to Shahbad sub-stretch and Shahbad to Ambala sub-stretch. A sub-stretch here is defined as the intersection of any National or State Highway with the NH 44, where major traffic flows would enter/exit. 2. One Multi-lane free flow gantry should be placed at the selected site on either side of the road on each of these 3 sub-stretches. This would mean a total of 6 such gantries might be required for the scope of this pilot project. The bidders are advised to visit the project stretch under consideration and create their own independent analysis of the number and size of gantries required.

3. The locations are tentative. The same is to be finalized in consultation with NHAI based on final design of the system. Tentative location will be 1 Km from the Toll Plaza.

4. The contractor shall design and develop systems pertaining to the following minimum specifications:

- The gantry equipment should consist of passive RFID readers which can capture and uniquely identify all the ETC FASTag enabled vehicles passing through the gantry during the entire duration of pilot.
- The gantry equipment should also consist of ANPR cameras which can capture license plate image of all vehicles passing through the gantry and perform 'Optical Character Recognition' on these images to uniquely identify the vehicle.
- The RFID readers shall be capable of reading ETC FASTags currently deployed, at normal running speeds of vehicles
- The exact quantity and specifications of each equipment can be at the discretion of the contractor while ensuring that the accuracy of data captured is as per requirements as mentioned in the RFP.

5. The gantry equipment installation should include, but not restricted to, the following components:

# a. RFID reader with below specifications or any higher specifications as per project requirement

- Standard: ISO 18000-6C
- Polarization pattern: Circular/ Linear
- Frequency range: 865-867 MHz
- Reading distance: 10-15 metres

• Any other specifications as deemed necessary by the contractor for capturing and identifying ETC-enabled vehicles at speed of maximum 150 km/hour with an accuracy of 99% (ninety-nine percentage) at least.

- b. Automatic Number Plate Recognition (ANPR) -enabled camera with below specifications or any higher specifications as per project requirement
- Frames per second: 60
- Megapixel: 3.0

• Any other specifications as deemed necessary by the contractor for capturing and identifying ETC-enabled vehicles at speed of maximum 150 km/hour with an accuracy of 80% at least on standard license number plates.

- c. Physical gantry hardware required to support the necessary mounted equipment (as per standard NHAI specifications)
- d. Cabling as necessary
- e. Hardware enclosure box for protection of cable and server equipment, as required
- f. Power and internet connectivity source to support the installation and integration of gantry design
- g. Any other component as per technical solution proposed by the contractor that may be required for uniquely identifying the ETC-enabled vehicles passing through the gantry and establishing the MLFF RFID barrier-less gantry based proof-of-concept.
- h. RFID system shall have an anti-collision function, to read multiple RFID tags at the same time.
- i. Channel Switching should be done within 6 milliseconds or faster.
- RFID Reader shall be capable to read the tag of moving vehicle with speed of up to 150 km/h.
- k. RFID Reader shall support minimum 4 radio channels for connecting 4 Antenna. Not more than 4 Antennas shall be connected to one RFID Reader.
- 1. The RFID channel switching should be customizable at the Control room application side.
- m. All the tags should be stored to reader internal memory before sending on the network.
- n. Air Interface Protocols ISO 18000-6C (EPC Class 1 Gen 2), ISO 18000-6C
- o. The reader shall operate only on the frequency of 865-867 MHz as specified in India.

- p. The equipment shall be designed to withstand the adverse climatic conditions that can arise on the location of installation of the road side equipment and shall be Suitable for 24x7 operations in open environment.
- q. The RFID reader and antenna shall have all applicable type approvals from WPC wherever relevant.

Any functionality not expressly stated in this bidding document but required to meet the needs of the project to ensure successful functioning of the system shall essentially be under the scope of the Successful Bidder and for that no extra charges shall be admissible for the same.

6. The performance tracking reports for each of the gantries should include data of each vehicle captured at the gantries in the following format:

- Timestamp
- ETC Tag ID (as per RFID reader data)
- Vehicle number (as per ANPR camera)
- Direction of movement of vehicle

7. The reports should also integrate the information captured from different gantries and the nearby physical toll plazas to create a vehicle-level database in the following format:

- Date
- ETC Tag ID (as per RFID readers data)
- ETC Tag ID (as per nearest toll plaza)
- Direction of movement of vehicle

8. Compliance reporting: Contractor shall validate the vehicles passing by against the report database on ETC vehicles crossing the nearest toll plaza as provided by NHAI.

# 4.4<u>IHMCL'S RESPONSIBILITY</u>

IHMCL will make available following to the successful bidder:

- Assistance (if so required) from the concerned highway concessionaire(s) for procuring the right-of-way on concerned stretches for placing on-road gantry units, including coordination with officers of NHAI at concerned Project Implementation Unit / Regional Office, etc.
- Required approvals and relevant documentation from NHAI and / or other stakeholders concerned with the highway stretch
- Intervening / calling meetings with the MLFF RFID Pilot Contractor on need basis to jointly discuss / finalize / brief the desired system / operational / functional requirement for achieving the desired results
- Providing ETC vehicle database from the nearest toll plaza for validation of vehicles passing by in order for Contractor to create the compliance report
- Provide sign-off on various reports, designs, etc. in course of the pilot POC.

# 4.5 CONTRACTOR'S RESPONSIBILITY/OBLIGATION

The MLFF RFID Pilot Contractor agrees and undertakes to fulfill the minimum service requirements/obligations. Broadly, these shall inter-alia include

- Covering the entire Service Area as prescribed under Section4.3.
- Setting up Multi-Lane Free Flow System based on Passive-RFID Gantry based design including the RFID on-road reader, ANPR-enabled camera as per requirements including all related civil and mechanical works on the highway.
- Using the same components of RFID reader/transceiver and ANPR camera from the OEM which have been deployed at least 2 RFID based MLFF tolling system approved by government agency anywhere in the world as referred in Section3.10
- The Contractor shall be responsible for arrangement and provision of all sources of electrical power including back-up, internet and communication for setting up the entire system.
- Strictly comply to the prescribed timelines and specifications.
- Operating and maintaining the MLFF RFID gantry system to meet the Service Level Requirement (SLR) prescribed under Section4.6.
- Compliance reporting: Shall provide all reports on time and in the frequency and format as following:

- Toll Plaza Data The Vendor will be required to setup its system to accept ETC data from selected Toll Plazas. The Data shall be transmitted at the end of day in the format shall be specified by IHMCL.
- Data Match report The Vendor shall generate the report to capture the match/mismatch between FASTag data read by the Gentries and corresponding Plaza data. The reports shall be generated on a daily frequency and shall capture the following data, at a minimum:
  - Aggregate count of Vehicles read by Gantry in the day
  - Aggregate count of Vehicles read by Plaza (basis data shared by IHMCL) in the day
  - Details of vehicle that could NOT be read by Gantry, but were detected at Plaza- count, class, time of operations
- Vendor Data The Vendor will also develop API to push the Gantry data to IHMCL on an hourly frequency. This report should have the following data – Number of FASTag, number of vehicle, time of operation. IHMCL may choose to randomly verify the Data Match report against this data and its own data sources.
- The MLFF RFID Gantry Pilot Contractor shall be responsible to comply with all statutory requirements concerning the subject matter viz. compliance to Labour Laws, Tax (es), employee insurance etc.
- The MLFF RFID Gantry Pilot Contractor to own the physical infrastructure (including but not limited to the readers, cameras and gantry crane) and dismantle the system and restore the site to original condition at the end of pilot duration.

# 4.6 SERVICE LEVELS

4.6.1 Contractor to submit a detailed gantry design architecture report within 30 days from the date of signing of contract agreement or date of issuance of instruction for commencement notice issued by IHMCL

4.6.2 Contractor shall complete the necessary installation and integration of all gantries, along with the required equipment, on the selected corridor within 60 days of submission of Gantry Architecture Report

4.6.3 Maximum gantry downtime, due to power failure or any other reason, to be not more than 15 minutes per day at each gantry

4.6.4 Maximum gantry downtime, due to power failure or any other reason, to be not more than 7 hours cumulative per month at each gantry

4.6.5 RFID readers to demonstrate at least 99% accuracy of ETC-enabled vehicle identification at each gantry

• Data captured to be corroborated with the ETC data collected from the nearest physical toll plaza as per data available with IHMCL on the same sub-stretch. Data accuracy compared to nearest toll plaza to be suitably modified to account for instances where tags not read at toll plazas but read at barrier-less gantries due to valid reasons.

4.6.6 ANPR cameras to demonstrate at least 80% accuracy of ETC-enabled vehicle identification at each gantry.

4.6.7. In case the System is not able to achieve an accuracy levels as specified in Clause4.6.5 and 4.6.6 for consecutive three weeks of operations, IHMCL may choose to adopt the following

- a. Notice to the Vendor regarding unacceptable system performance and to fix the system by ensuring the discrepancy does not exceed 5% of the specified levels.
   Within a period of two (2) weeks ("Curing Period")
- b. If the Bidder is not able to bring the system as per specifications within the Curing Period, IHMCL reserves the right to terminate the Contract with the Vendor as per conditions specified in the Contract.

#### 4.7 PROJECT DURATION:

The initial phase ("Go-Live") of pilot engagement shall be 03 months from date of signing of Contract Agreement for designing and installing the MLFF gantries. The second phase of pilot duration shall be 03 months from the date of pilot Go-Live for operating & maintaining the gantry hardware and software and reporting the performance of these gantries as per the Terms of Reference of this pilot. The period of pilot duration may be further extendable by upto 06 months at the sole discretion of IHMCL/MoRTH at mutually agreed terms and conditions.

#### **PART - V: CONDITIONS OF CONTRACT**

#### 5.1 CONDITIONS OF CONTRACT

These Conditions shall supplement or amend the other parts of the Bidding Documents and whenever there is a conflict; provision herein shall prevail over those in the other parts of the Bidding Documents.

#### 5.2 GOVERNING LANGUAGE

All correspondence and other documents to be exchanged by the parties shall be written in the English language. The version written in English language shall govern its interpretation.

#### 5.3 APPLICABLE LAW

Appropriate laws as in force in Republic of India shall apply.

#### 5.4 Project Scope

The scope of project shall include activities as specified in RFP.

#### 5.5 INTERPRETATION

In interpreting these Conditions of Contract, singular also means plural, male also means female or neuter, and the other way around. Headings have no significance. Words have their normal meaning under the language of the Contract unless specifically defined. The Bidders are expected to examine all terms and instructions included in the RFP Document. During preparation of the proposal, the bidders shall make their own assessment of staff to undertake the assignment.

#### 5.6 RIGHT TO AMEND PROJECT SCOPE

IHMCL retains the right to amend the Project Scope without assigning any reason at any time during the Contract Period. IHMCL makes no commitments, express or implied, that the full scope of work as described in this RFP will be commissioned.

#### 5.7 PAYMENT TERMS

- a) Payments will be made in Indian Rupees only.
- b) The payment milestones shall be as per the following table:

c) All payment will be subject to penalty and/or adjustments as per conditions mentioned in this document and shall be released within 30 days from the date of undisputed invoice.

# 5.8 Damages

- a. Delay in design, engineering & installation: If service contractor fails to supply, design, and engineer and install the gantry based design as per timelines, penalty of Rs. 50,000/- per day upto maximum of Rs. 50,000/- shall be applied.
  In case of delay beyond 20 days, IHMCL may consider termination of contract or forfeiture of the performance security or both.
- Each issue/concern highlighted during the contract period must be addressed within 24 hours of written notice/email from IHMCL. For which start time shall be the time of email forwarded/issued by IHMCL.

- c. Any delay in rectification of issue during the service period, except in Force Majeure situations, shall attract penalty of INR 5,000/- (Five Thousand Indian Rupees) per day subject to a maximum of INR 50,000/- (Fifty Thousand Indian Rupees) for each instance.
- d. Damages shall be payable by the Service Provider within 5 days of imposition thereof by IHMCL, failing which the same shall be deducted from the payments to be made to the Service Contractor or from the Performance Security as deemed appropriate by IHMCL.
- e. At any time during Contract Period, if IHMCL observes that there are significant variations in observed results and the performance level required (specified in relevant sections of RFP), IHMCL shall have the right to terminate the Contract Agreement and consider forfeiture of the security deposit. In such case, IHMCL may consider, at its sole discretion, any of the following recourse:
  - (i) instruct the successful bidder to install Corrective measures (ref. Annexure A) at no additional cost to IHMCL (failure to comply to the same by the successful bidder will be considered a breach of contract conditions), or
  - (ii) award the contract/work to the next lowest cost bidder (i.e. L2), or
  - (iii) Take any action as may be deemed fit to IHMCL.

# 5.9 PRICES

- a) GST as applicable, which will be levied on the goods and services invoiced by the Service Provider to IHMCL, will be reimbursed on actual basis.
- b) IHMCL reserves the right to ask the Service Provider to submit proof of payment against any of the taxes, duties, levies indicated.
- c) All payments shall be made subject to adjustment of applicable damages.
- d) No amount or cost shall be payable for holding discussion, as considered necessary by IHMCL, for any purpose with IHMCL's Officials at IHMCL's Head Office or elsewhere, prior, during or after the conduct of an assignment.
- e) Prices quoted by the bidder shall be excluding GST and fixed for the entire Contract period.

### 5.10 CONTRACT PERIOD

The initial phase ("Go-Live") of pilot engagement shall be 03 months from date of signing of Contract Agreement for designing and installing the MLFF gantries. The second phase of pilot duration shall be 03 months from the date of pilot Go-Live for operating & maintaining the gantry hardware and software and reporting the performance of these gantries as per the Terms of Reference of this pilot. The period of pilot duration may be further extendable by upto 06 months at the sole discretion of IHMCL/MoRTH at mutually agreed terms and conditions.

## 5.11 INSURANCE

The Service Provider shall effect and maintain at its own cost, during the Contract period, such insurances for such maximum sums as may be required under the Applicable Laws, and such insurances as may be necessary or prudent in accordance with Good Industry Practice to cover third party claims, theft, accidental damage, vandalism, fire, flood, and Force Majeure events.

## 5.12 FORCE MAJEURE

- a) Neither party shall be responsible to the other for any delay or failure in performance of its obligations due to any occurrence of a Force Majeure event which is beyond the control of any of the Parties, including, but without limited to, fire, flood, explosion, acts of God or any governmental body, public disorder, riots, embargoes, or strikes, acts of military authority, epidemics, strikes, lockouts or other labour disputes, insurrections, civil commotion, war, enemy actions.
- b) If a Force Majeure arises, the Service Provider shall promptly notify IHMCL in writing of such condition and the cause thereof. Unless otherwise directed by IHMCL, the Service Provider shall continue to perform his obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event. The Parties shall be excused from performance of their respective obligations in whole or part as long as such Force Majeure event continues to prevent or delay such performance by the Parties. However, in case such Force Majeure event lasts for a continuous period of 60 days, either Party may terminate the Contract.

# 5.13 INDEMNIFICATION

- a) The Service Provider shall indemnify, defend, save and hold harmless, IHMCL,NHAI and MoRTH and their officers, servants, agents (hereinafter referred to as the "IHMCL Indemnified Persons") against any direct loss, damage, claims, cost and expense of whatever kind and nature (including without limitation, legal fees, claims and expenses incurred in connection with any suit, action or proceeding or any claim asserted, as such fees and expenses are incurred), joint or several, that arise out of or are based upon any order passed by any statutory authority including Courts, tribunals or other judicial/quasi judicial authorities, on account of breach of the Service Provider's obligations under this Contract or any other related agreement or otherwise, any fraud or negligence attributable to the Service Provider or its Agents under contract or tort or on any other ground whatsoever, all eventualities of theft, dacoity, robbery, etc., except to the extent that any such suits, proceedings, actions, demands and claims has arisen due to any breach or default of this Contract on the part of IHMCL Indemnified Persons.
- b) The Service Provider shall indemnify IHMCL Indemnified Persons from all legal obligations in respect of professionals deployed by the Service Provider. IHMCL Indemnified Persons also stand absolved of any liability on account of death or injury sustained by the Service Provider's staff during the performance of their work and also for any damages or compensation due to any dispute between the Service Provider and its staff.
- c) In addition to the aforesaid, the Service Provider shall fully indemnify, hold harmless and defend IHMCL Indemnified Persons from and against any and all direct loss, damage, cost and expense of whatever kind and nature (including, without limitation, legal fees and other expenses incurred in connection with any suit, action or proceeding or any claim asserted, as such fees and expenses are incurred), joint or several, that arise out of, or are based upon any demands, claims, suits or proceedings arising out of claims of infringement of any domestic or foreign patent rights, copyrights or other intellectual property, proprietary or confidentiality rights with respect to any materials, information, design or process used by the Service Provider or by the Agents in performing the Service Provider's obligations or in any way incorporated in or related to this Contract. If in any such suit, action, claim or proceedings, a temporary restraint order or preliminary injunction is granted, the Service Provider shall make every reasonable effort, by giving a bond (of the type and value as required) or otherwise, to secure the revocation or suspension of the injunction or restraint order and continue to

perform its obligations hereunder. If the Service Provider is unable to secure such revocation within a reasonable time, it shall, at its own expense, and without impairing the Specifications and Standards, shall rectify such defaults and shall also be liable for damages to IHMCL for the corresponding loss during the interim period on this account.

- d) The provisions of this Clause shall survive Termination.
- e) The remedies provided under the Clause are not exclusive and shall not limit any rights or remedies that may otherwise be available to IHMCL Indemnified Persons at law or in equity.

# 5.14 TERMINATION

- a) ON EXPIRY OF THE CONTRACT: Subject to the condition mentioned under the RFP, the Agreement shall be deemed to have been automatically terminated on the expiry of the Contract Period unless IHMCL has exercised its option to further renew the Contract Period in accordance with the provisions, if any, of the Contract.
- b) ON ACCOUNT OF FORCE MAJEURE: Either party shall have the right to terminate the Contract on account of Force Majeure, as set forth in the RFP.
- c) ON ACCOUNT OF NON PERFORMACE: If IHMCL observes performance is not as per service levels specified in RFP, IHMCL shall ask the Solution Provider to fix the issue within seven (7) days of the incidence. In case the Solution Provider is not able to resolve the issue within seven (7) days, IHMCL may choose to terminate the Contract.
- d) ON BREACH OF CONTRACT: IHMCL may terminate the Contract if the Service Provider causes a fundamental breach of the Contract. Fundamental breach of Contract includes, but shall not be limited to, the following:
  - i. The Service Provider fails to carry out any obligation under the Contract.
  - ii. The Service Provider without reasonable excuse fails to commence the work in accordance with relevant clauses.
  - iii. Has failed to furnish the required securities or extension thereof in terms of the Contract.
  - the Service Provider stops work and the stoppage has not been authorized by IHMCL;
  - v. the Service Provider at any time during the term of the Contract becomes insolvent or makes a voluntary assignment of its assets for the benefit of creditors or is adjudged bankrupt
  - vi. If the Service Provider, in the judgment of the Employer, has engaged in the

corrupt or fraudulent practice in competing for or in executing the Contract.

- e) The Service Provider sub-contracts any assignment under this Agreement without approval of IHMCL.
- f) Any other fundamental breaches as specified in the RFP.
- g) Notwithstanding the above, IHMCL may terminate the Contract in its sole discretion by giving 30 days prior notice without assigning any reason.
- h) Upon Termination (except on account of expiry of Term of this Agreement, Force Majeure), IHMCL shall be entitled at the sole discretion to:
  - i. appropriate the entire Performance Security or part thereof as Damages; and
  - ii. Debar/Blacklist the Service Provider from participating in any other project/assignment/work of IHMCL for a period as determined by IHMCL in its sole discretion.
- 5.15 Appropriation of Performance Security
  - a) Upon failure of the Service Provider to commence the services, for any reason whatsoever, within the period set forth in this Contract or the extended period thereunder, IHMCL shall, without prejudice to its other rights and remedies hereunder or in law, be entitled to levy Damages as per relevant Clause hereinabove.
  - b) IHMCL shall, without prejudice to its other rights and remedies hereunder or in law, be entitled to encash and appropriate the relevant amounts from the Performance Security as Damages or any other amounts payable to IHMCL under this Contract as and when such Damages or other amounts become due and payable.
